Virtual Safety Inspections - April 9-11, 2025

- Separate from FRR due to this year's calendar adjustment
- Planning for Virtual Safety Inspections with Tripoli Wisconsin
 - Inspections take place April 9-11
 - Virtual Safety Inspection schedule will be booked similar to other milestones, meetings will be 10-15 minutes each Judges may be in attendance
 - NEW: Teams will prepare/discuss Pre-Launch Checklist Check Tools & Tips
 - Rockets 95-100% Ready to Fly
- Virtual Safety Inspection will involve:
 - A Zoom meeting where students show the status of the construction of the rocket to date
 - The construction of the rocket must be sound fillets, bulkheads, rail buttons, recovery hardware and attachments, fitment, will be examined
 - Teams will be scored on their flight readiness (pre-launch checklist)
 - Pre-Launch Checklist is being reviewed/updated and will be posted to the website for teams to have access to and prepare for the inspection
 - Suggestions/corrections must be made prior to launch weekend arrival for final safety inspection on Friday
- Ensure you submit a recent RockSim file prior to inspection

Competition Launch Day Expectations

- There are a few WSGC items to observe on Launch Day
 - Launch site opens at 7:30 am
 - Kick-off/Safety Meeting at RSO table at 8:00 am
 - Pre-launch group/team photo with Steve Janiak, photographer
 - Video/photos throughout the day for WSGC media purposes
 - Team members wear FNL T-Shirt at launch site
 - Lanyards identify which advisors/team members are not a TRA/NAR member, limiting access to launch area
 - Only 3 individuals from each team may go to the launch pad (Advisor/2 students)
 - Individuals aged 12-17 must be accompanied by a TRA/NAR member of the same motor impulse being launched
 - Individuals may conduct certification launches after their team completes the competition launch
 - Individuals conducting certification launch should notify Connie prior to launch weekend
 - All teams must be cleared by the pit crew before going to the RSO table
 - Altimeter Flight Data must be turned in before departing the launch site



Post Launch Day Expectations

- Post Launch Assessment Report (PLAR)
 - Due May 12th
 - Summary of vehicle performance, challenge performance and comparison to predictions – share lessons learned
- Final Reimbursement Requests Due May 12th





Reimbursements

- Reimbursements are determined by your award document
- Verify the method selected, we must receive an email with an updated and signed award document from the advisor of record to change the reimbursement method
 - Reimbursement to Organization (School/Student Organization)
 - Requires Institutional W-9 sent in
 - Reimbursement to individuals
 - Individual W-9 required in following situations:
 - All advisors that are receiving stipends
 - Students that win competition awards (i.e., Patch Contest)

Advisors

Stipend breakout

- \$500 for on-campus activities
- \$500 for competition weekend must travel to the competition

Mentors
